It is expected that the changes will take effect on or around 27 November 2020 in the Prospectus and the updated Prospectus will be available to investors free of charge. Whilst the change described below do not require Shareholder approval, should you wish to redeem your shareholding, you may do so in accordance with the dealing provisions outlined in the Prospectus.
